Programme information and content

The aim of the LLB is to provide legal education not only in the core areas of English law required to be awarded a qualifying law degree (QLD) but also in a variety of specialisms that enrich the student's experience and understanding of how law is used to solve disputes or achieve change.

The overarching educational aim of this course is to not only impart legal knowledge but: to situate the law and international business practice within wider global, national policy and practice contexts; to equip students with skills necessary for research, critical analysis, and application of law in a range of issues; and to provide opportunities for students to start developing the skills crucial to legal practice.

This programme will also provide students with an understanding of the practice, concepts and theories of international business management within a global environment.

Students will develop the skills and competencies necessary to apply their legal and business knowledge to practice in the context in an increasingly global economy.

Part 1:	<p>In Part 1, you will be supported in developing legal skills, and will be introduced to the teaching methods and expectations applicable to higher legal education. You will study four key areas of English law: contract, tort, criminal and public law, and practise applying the law to hypothetical scenarios to provide targeted advice to fictitious clients, as well as developing your ability to analyse the law from a critical perspective.</p> <p>Additionally you will study one compulsory business module which will develop core knowledge and skills on the topics of the international market, marketing and international business management.</p>

Part 2:	<p>In Part 2, you will study the compulsory subjects in the qualifying law degree. You will also be able to choose one optional module from the School of Law. You will study two compulsory modules on accounting and the global economy.</p> <p>You will continue to develop your legal skills and ability to work with primary legal resources, to research the law and justify your conclusions.</p> <p>The study of global economy provides you with a more in-depth understanding of core principles in international business</p>
Part 3:	<p>In the final year, students must choose one compulsory independent research-based modules to demonstrate mastery of legal writing, legal research and the construction of a legal argument.</p> <p>In addition, you will study one compulsory law module, (Equity) you will then be able to choose two optional modules for law and two optional modules international business – one per semester.</p> <p>Part 3 gives students the opportunity to advance their legal and business knowledge and skills and specialise in different areas related to international business.</p>

4	Evaluate legal problems and propose workable and amicable solutions.
5	Critically assess sources and materials to construct arguments both within the legal and business environment.
6	Apply information management and application skills to law and international business.
7	Develop analytical, problem-solving and applicative approaches to interpretation of law, as well as applying these key skills within the business modules, in particular accounting.

8	Produce coherent and convincing arguments and to engage in critical thinking and debates.
9	Act ethically, professionally and with integrity as a legal professional and apply effective managerial and entrepreneurial practices to make effective decisions.
10	Communicate effectively in written and various other communication mechanisms across the two disciplines.
11	Develop personal and professional strategies to lead and work in teams.
12	Acquire holistic knowledge, and relevant professional skills required of a successful law graduate with an international business perspective.

You will be expected to engage in learning activities to achieve these Programme learning outcomes. Assessment of your modules will reflect these learning outcomes and test how far you have met the requirements for your degree.

Optional modules:

The optional modules available can vary from year to year. An indicative list of the range of optional modules for your programme can be found online in the Course Catalogue. Details of optional modules for each part, including any additional costs associated with the optional modules, will be made available to you prior to the beginning of the Part in which they are to be taken and you will be given an opportunity to express interest in the optional modules that you would like to take. Entry to optional modules will be at the discretion of the University and subject to availability and may be subject to pre-requisites, such as completion of another module. Although the University tries to ensure you are able to take the optional modules in which you have expressed interest this cannot be guaranteed.

Teaching and learning delivery:

You will be taught primarily through a mixture of lectures, workshops, seminars and tutorials, depending on the modules you choose. Elements of your programme will be delivered via digital technology. The contact hours for your programme will depend upon

your module combination; an average for a typical set of modules on this programme is around 220 hours.

Elements of your programme will be delivered via digital technology.

The scheduled teaching and learning activity hours and amount of technology enhanced learning activity for your programme will depend upon your module combination. In addition, you will undertake some self-scheduled teaching and learning activities, designed by and/or involving staff, which give some flexibility for you to choose when to complete them. You will also be expected to undertake guided independent study. Information about module study hours including contact hours and the amount of independent study which a student is normally expected to undertake for a module is indicated in the relevant module description.

Accreditation details

Please note that the School of Law intends that the LLB will be a UK qualifying law degree (QLD), where still relevant, for all students and will make any necessary changes to the degree programme to ensure it stays a QLD or continues to satisfy any modified professional requirements for the academic stage of training stipulated by the professional bodies. All other aspects of the degree programme may be subject to change where such change is educationally desirable or practically necessary.

Assessment

The programme will be assessed through a combination of different types of assessments including more traditional methods such as written examinations and coursework (including through presentations and podcasts) as well as, for example, participation in advocacy or negotiation, writing client letters and writing reflectively about learning experiences. Further information is contained in the individual module descriptions.

Progression

Part 1

To achieve a threshold performance at Part 1, a student will normally be required to:

- (i) Obtain an overall average of 40% over 120 credits taken in Part 1;
- (ii) Obtain a mark of at least 40% in individual modules amounting to not less than 80 credits taken in Part 1; and
- (iii) Obtain marks of at least 30% in modules amounting to 120 credits.

In order to progress from Part 1 to Part 2, a student must achieve a threshold performance; and

- (iv) obtain an overall average of 40% across all credits taken for which a numerical mark is awarded in Part 1; and

(v) obtain a pass of at least 40% in LW1ELS, LW1CON, LW1CRI, LW1PL1, and LW1TOR.

Students who achieve a threshold performance only at Part 1 will be eligible for transfer to LLB Legal Studies.

The achievement of a threshold performance at Part 1 qualifies a student for a Certificate of Higher Education if they leave the University before completing the subsequent Part.

Transferring from a Joint Honours to a Single Honours programme

Students are able to transfer from a Joint Honours to a Single Honours programme in one of their joint subject areas at the end of Part 1, subject to fulfilling the Part 1 University Threshold Standard, achieving marks of at least 40% in at least 40 credits of modules in the subject to which they wish to transfer, and fulfilling any programme-specific progression rules for the Part 1 Single Honours Programme to which they wish to transfer.

Students who transfer from a Joint Honours to a Single Honours programme may not have taken all of the Part 1 modules listed in the Single Honours Programme Specification. The modules which they have taken will be shown on their Diploma Supplement.

Part 2

To achieve a threshold performance at Part 2, a student shall normally be required to:

- (i) Obtain a weighted average of 40% over 120 credits taken in Part 2; and
- (ii) Obtain marks of at least 40% in individual modules amounting to at least 80 credits taken in Part 2; and
- (iii) Obtain marks of at least 30% in individual modules amounting to at least 120 credits, except that a mark below 30% may be condoned in no more than 20 credits of modules owned by the Department of Mathematics and Statistics.

In order to progress from Part 2 to Part 3, a student must achieve a threshold performance; and

- (iv) obtain marks of at least 40% in LW2EUL, LW2LND, and LW2PL2

Students who achieve a threshold performance only at Part 2 will be eligible for transfer to LLB Legal Studies.

The achievement of a threshold performance at Part 2 qualifies a student for a Diploma of Higher Education if they leave the University before completing the subsequent Part.
